Course Overview

This course is designed to meet industry guidelines through the IWCF[™] Level 2 curriculum and learning objectives. It presents a body of knowledge and a set of job skills that can be used to provide surface stack well control knowledge and skills for drilling operations.

The course focuses on the floor hands, shakerhands and other rig-based personnel who are primarily tasked with kick detection, as it introduces and addresses basic principles and theories of well control.

Some of the topics covered in this course are: well control concepts, calculations, mud & pit management, risk management, causes of kicks, abnormal pressure warning signs, kick detection, shut-in procedures



and verification (surface and subsea), post shut-in monitoring & activities, well control drills, well control methods, kill sheet and pre-recorded data, and equipment.

A candidate must receive a score of 70% or more in all both assessments (equipment, and principles and procedures) to successfully complete the course.
